 - Great turnout for the mentoring panel. Creating space to showcase that you are not alone and that we are here to support/resource. There was an unfortunate fire alarm towards the end of the session that stopped the session.

 - a) Shaunak Sastry the mentoring panel was great. Notes on how other divisions also started implementing the mentoring panel that this division/caucus started.
 - b) Suggestion from the floor: Maybe we need bigger space? Shaunak Sastry – it depends on NCA's projection of how many

- people would come. Andy Kai-chun Chuang 64 preregistered members and more people actually came (people who didn't register). This year, we estimated 70 based on the registration. Maybe we can consider projecting 100 for next year to get a larger space.
- c) Idea from the floor: Would GIFT format be better? Andy Kai-chun Chuang— or maybe like the Scholar's Office? Richie Neil Hao we will consider these ideas for next year's program planning.

- VI. Amendments to Bylaws (Richie Neil Hao)
 - A. Article 4 Section 3: Minor line addition ("The 2nd Vice-Chair-Elect shall lead the planning for and coordinating of the annual mentoring panel"). Majority-vote and approved.
 - B. Article 4 Section 7: Language addition ("The Chair shall succeed to the office of Past Chair. The Past Chair shall hold a one-year position as a chair of the caucus and division's Nominating Committee. The Past Chair shall also serve as the caucus and division's representative on NCA's Nominating Committee"). Majority-vote and approved.
 - C. Article 4 Section 8: Term change from "Diversity" to "IDEA." Majority-vote and approved.
 - D. Article 4 Section 12: Change proposal about the election process to switch to online ballot.
 - Shaunak Sastry follow-ups on the reason for the change.
 - Zhuo Ban addresses the issue of the floor nomination at the NCA Business Meeting.
 - Question from the floor Does all the voting happen before NCA? Richie Neil Hao Either way, we're only proposing the election to be held online (timeline to be determined).
 - Question from the floor For voting, membership to this division/caucus has to be active? Richie Neil Hao & Shaunak Sastry Yes.
 - Question from the floor Can people who are not participating in person participate in the business meeting (e.g., awards)? Richie Neil Hao At this time, we cannot promise reliable Internet access at the physical convention location to hold the business meeting.
 - Comment from the floor (About the online ballot) There might be people who are not invested in the division/caucus vote. And I am personally not comfortable with online voting without knowing the specific procedures (e.g., timeline). Richie Neil Hao That's something that needs to be discussed for next year. Comment from the floor My response to who I

may vote for might be different before and after the NCA. I like hearing voices from candidates. Instead of A or B (nominations sent by nominating committee or nominations from the floor), what about A and B? Shaunak Sastry – For the NCA ballot, their system will host the election for us. Last year, we solicited the nomination from the floor at NCA Business Meeting, then, sent the information to the NCA officer. There was fairly decent participation. They also secure the ballot. Richie Neil Hao – In responding to the earlier point, we can put the language of "division members only" in the bylaw for online voting participation. Is there any support at all for the online format for this year (yes or no)? 3/21 supported the online voting to be in effect this year (did not approve). We will not change it for this year. We will discuss the details for next year.
